# RADIO & INTERNET AUDIO BROADCAST KSHSAA ACTIVITIES AGREEMENT

who is empowered with the authority to act in behalf of Kansas State High School Activities Association (KSHSAA) member schools, enter into the following agreement as approved by the Kansas State High School Activities Association Executive Board.

The above named station is granted broadcast rights for the activity listed above and agrees to the following stipulations:

1. That no charge be made to the radio station for the broadcast rights to the above mentioned activity.
2. That before the beginning of the broadcast for each contest/event, the announcer shall state: "This activity is being brought to you by this station, its advertisers and the member schools of the Kansas State High School Activities Association. No rebroadcast, in whole or in part, may be made without the written permission of the KSHSAA."
3. That permission by the KSHSAA for this broadcast is being given with the understanding that this station will have, during the current school year, carried public service announcements in behalf of the KSHSAA, supplied by the Kansas State High School Activities Association and the Kansas Association of Broadcasters.
4. That no individual or organization be permitted to sponsor a broadcast for the purpose of advertising alcoholic beverages, tobacco or any other product which is contrary to the principles of good high school activity training. That NO political parties or candidates be allowed to sponsor any of the broadcasts.
5. That no commercial may relate, directly or indirectly, the advertising or the advertised product to the schools or students involved, or the KSHSAA itself.
6. That the KSHSAA reserves the right to discontinue this agreement at any time in the event any of these stipulations are violated or any aspects of the station's broadcasting is considered to be in poor taste or incompatible with the educational objectives of the Association.
