- 11. **Board of Director Meeting Breakout Debrief** As part of the April 27 Board of Directors meeting, respective classifications of schools conducted breakout sessions to discuss critical topics which may require action or further study, including placement on the Regional Administrator Meeting agenda. - 13. **Executive Session** The Executive Director requests a 15-minute Executive Session with the current and future Executive Board members, along with administrative staff, for the purpose of providing a legal update with KSHSAA counsel, Kevin Fowler.
- 14. **HUDL Partnership** At the April Executive Board meeting, staff recommended approval of the HUDL Cross Promotion Agreement. Dollars received from this partnership would support Officiating Services by providing funding for officiating scholarships, RefReps scholarships, and continued growth of KSHSAA officiating clinics. Staff will lead the discussion with the board to address other questions posed during April meeting and recommends approval of this partnership. *See Support Material* (**Discussion, Action**)
- 15. **Soccer Manual Updates** At the April Executive Board meeting, staff recommended changes to the KSHSAA Soccer manual relative to mercy rule and the tie breaking procedure used in postseason. At the request of the Executive Board, additional information has been collected and included in the support material. Staff recommend the adoption of the 8-goal difference (halftime or after) as the game ending differential, and the approval of two-10 minute sudden victory overtime periods followed by penalty kicks as the designated postseason tiebreaking procedure. *See Support Material* (**Discussion**, Action)

- 16. **KSHSAA Policies** Annually, staff evaluate and recommend possible changes for policies, membership dues and fees. While there is no recommended change to membership dues, staff recommend approval of the changes to fees noted in support material. *See Support Material* (**Discussion, Action**)
- 17. **3-1A Basketball postseason format** Per continued discussion at recent Executive Board meetings, the Executive Board will consider approval of modifications to the 3A, 2A, and 1A boys and girls postseason basketball format. *See Support Material* (**Discussion, Action**)

18. Championship Format –

- A. **Basketball** Currently, all seven classifications in basketball conduct championship tournaments in different communities. Based upon input from membership and in response to an Executive Board request, staff will provide the details regarding the option to schedule championship tournaments (quarterfinals, semifinals, consolation and championship games) being played at four venues in one community during the traditional four days of state basketball starting in March 2026.
- B. Wrestling Starting next season, with the anticipated continued increase in girls wrestling participation, staff recommends the girls classifications mirror the boys classifications for all postseason tournaments. This creates both a boys and girls 6A, 5A, 4A, and 3-1A championship tournament. Pending confirmation of the availability of a suitable fourth venue, staff recommends each state championship tournament be conducted as a two-day tournament, each at unique venues with boys and girls within a class competing concurrently at the same venue.

- 19. **KAMS Follow Up** At the March Executive Board meeting, the board received a request for the Kansas Academy of Math and Science to be a member of the KSHSAA. Previously, KAMS has been an Approved School. KAMS is under the jurisdiction of the Kansas Board of Regents per statute 72-3904 (in support material). KAMS has not provided any accreditation documentation. The Board is asked to make a determination on membership. *See Support Material* (**Discussion, Action**)
