### **Baseball - Pitch Count Rule**

5. A rules change by the NFHS Baseball Rules Committee (*NFHS Rule 6-2-6*) requires all state associations to adopt a pitch count rule for baseball pitchers effective with the upcoming 2017 season. Using data collected during the 2016 season, the KSHSAA convened a committee of veteran coaches from around the state to develop a pitch count policy for Kansas. The policy, as seen on page four, is proposed by the committee.

### **Proposed KSHSAA Pitch Count Rule**

### Effective 2017 Baseball Season

NFHS Baseball Rule 6-2-6 now states, "Each NFHS member state association will be required to develop its own pitching restriction policy based on the number of pitches thrown during a game to afford pitchers a required rest period between pitching appearances."

### We propose:

<u>Pitches</u>	<b>Required Rest</b>
76-105	4 days
61-75	3 days
46-60	2 days
31-45	1 day
1-30	0 days

#### More Information:

- The above pitch count chart applies to all levels of competition.
- Required rest means calendar days. Throwing 105 pitches on Monday means the required rest
  period will be Tuesday, Wednesday, Thursday and Friday. The first available day to return to
  competitive pitching is Saturday.
- A player's pitch count and required days of rest apply to games at any and all levels of play.
  - Example: Player A throws 62 pitches in a junior varsity game. Player A must rest 3 days before pitching in a JV, Varsity or other sublevel game.
- Number of pitches are competitive pitches only. Warmup or bullpen pitches do not count.
- \*A pitcher will be allowed to finish a batter if they reach the max of 105 in the middle of the at bat.

Penalty: Violation of the maximum pitch count (105)\* in one day or the required rest that accompanies the respective pitch count will result in immediate ineligibility of the violating player and coach. Ineligibility remains until reinstated by the KSHSAA. The game in which the violation occurs will result in forfeiture.

All violations must immediately be reported to the KSHSAA.

### **Recording of Pitch Counts**

<u>Game day:</u> NFHS Baseball Rule 9-2-2 denotes that..."The scorebook of the home team shall be the official scorebook, unless the umpire-in-chief rule otherwise..."

- The official scorer(s) will keep track of pitch counts for both teams at all levels of competition.
- The KSHSAA will provide an official pitch count tracking sheet to each school for use.
- Each head coach will sign the sheet after each game. This will insure each coach/school
  understands the required rest of their pitchers. The host school will archive each sheet.
- The official scorer should record all pitches thrown to the batter; ball, strike, foul, legal or illegal.
- When a pitcher approaches one of the benchmarks (30, 45, 60, 75 & 105 pitches) of the pitch count rule, the official scorer will inform the respective coach of that pitcher.
- Coaches will be required to input data into KSHSAA website within 24 hours of completed competition. This data will only be visible to baseball schools.

Pitch count or scorebook applications (example: *Gamechanger*) may be used to keep track of pitches. The pitch count sheet must still be signed by coaches and official scorer and retained on file by the home team.

\*Note: In 2015-16, 97 schools were classified as 1A. Cooperative team agreements in Class 1A resulted in 88 basketball teams and 85 volleyball teams participating.

### ARTICLE XII

### **Classification of Senior High Schools**

**Section 1:** A classification system shall be established for senior high schools involved in interscholastic activities under the supervision of the KSHSAA.

**Sec. 2:** The classification system for each activity is based upon criteria developed and approved by the KSHSAA Board of Directors.

**Sec. 3:** The Executive Board may combine or separate Classes at any time if the number of participating schools in an activity so warrants.

**Sec. 4:** Modification of the classification system may be proposed by the KSHSAA Board of Directors, the Executive Board, or by petition from a member school. A petition must be signed by the principal and superintendent of at least 20 percent of the schools in the Classes modified by the proposal and presented to the KSHSAA Executive Director by December 1 of any school year. Any proposal, before it becomes effective, shall be approved first by the KSHSAA Board of Directors, and second, by a majority of all schools affected and a majority of all Classes affected. When only two Classes are affected, the proposal must have a majority support from each Class.
