

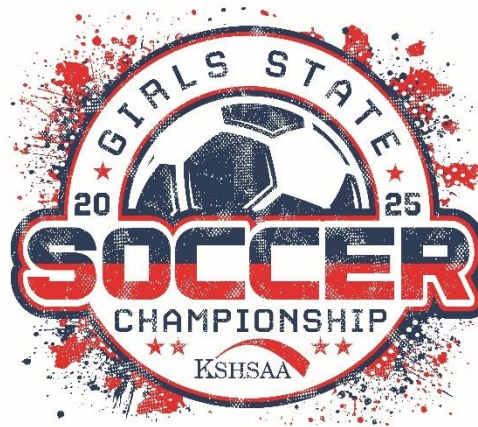

2024-25 RULES MEETING & EXAM

NEW THIS YEAR: All assistant coaches are required to complete a rules meeting. 2024-25 KSHSAA SOCCER MANUAL CHANGES

After reviewing survey data from member schools who participate in soccer, the KSHSAA Executive Board approved the following two changes to the KSHSAA Soccer Manual:

- Reduced the 10-goal differential to 8 throughout regular season and postseason play.**
Rationale: Primary reason is risk/injury mitigation. This remains applicable only after one complete half of play. Number of goals scored is not a postseason seeding criteria.
- Removed the two 5-minute sudden victory overtime periods in postseason play.**
Postseason contests ending regulation with a tie score will play two 10-minute sudden victory periods and then proceed to penalty kicks when needed.
Rationale: Primary reason is risk/injury mitigation. Align more closely with regular season overtime procedure which is two 10-minute sudden victory periods.

GUIDANCE FOR COACHES & ATHLETES

KSHSAA RULE 22 – Once a student begins practice with a school team, the student may not play on an outside/club/rec team in the same sport/activity during the school season.

KSHSAA RULE 26-1-4 – A student shall not participate in group training sessions or tryouts held by outside agencies **other than colleges** in a sport while he or she is a member of a school athletic team in that identical sport. *NEW THIS YEAR: Schools may allow athletes to attend college tryouts/ID camps hosted by colleges during the school soccer season.*

KSHSAA RULE 30-1-6a – Schools may not hold interschool scrimmages (practices) in athletics. Interschool is defined as middle/junior school with another middle/junior school and senior high school with another senior high school. **This does not eliminate scrimmages between alumni and the school team.** During a scrimmage there can be no score kept and no clock. Use of officials is permitted. Should one or more game elements (score or time) be involved, it would no longer be a scrimmage but must count toward the number of contests allowed during the season. Intrasquad scrimmages, games among teammates, even with score, time and/or officials used would not be considered a game.

SPRING SOCCER PLAYERS NOT REQUIRED TO HAVE 9 DAYS OF PRACTICE

In September 2021, the KSHSAA Board of Directors approved a modification to Soccer Rule 38-1-2 making the nine-day practice requirement applicable only to the fall soccer season. Now, only fall activities have minimum practice requirements before competing primarily for heat acclimatization concerns.

JAMBOREES FOR HIGH SCHOOL SOCCER

The purpose for these controlled playing opportunities is to provide a meaningful, learning and training experience for players, coaches, and officials. Jamborees must take place prior to regular season competitions and include 3 or 4 KSHSAA member schools. Participating athletes must have at least 5 prior practices. KSHSAA registered officials are required. It is strongly encouraged to use jamborees as training opportunities for officials. Time should be scheduled during a jamboree for officials to review rules changes and sportsmanship expectations with players and coaches. EMERGENCY ACTION PLAN (EAP) – Recommended Rehearsal Date is March 12.

- An emergency action plan should be in place for every sport, team and venue.
- For assistance in developing an EAP or finding additional resources to improve your EAPs, click [HERE](#).
- The emergency action plan should be rehearsed by EVERYONE involved, at least one time annually.
- **An automated external defibrillator (AED) should be readily available at any practice or competition.**
- **Review the PPE.** Be sure your coaches are aware of any pre-existing conditions in their student-athletes that were indicated on their PPE (e.g., allergies, asthma, diabetes, cardiac abnormalities, sickle cell trait, concussion history, required medications, etc.).



OFFICIAL BALL FOR KSHSAA POSTSEASON SOCCER

The KSHSAA is proud to partner with SELECT and have the SELECT Royale as the official postseason ball for KSHSAA soccer. Balls will be provided by the KSHSAA to host schools/sites for each postseason contest. Balls used for regular season contests are at the discretion of the host school. They must have the NFHS authenticating mark.

UNIFORMS

The home team wears dark colored jerseys and socks (clear contrast to white), and the visiting team wears solid white jerseys (no colored piping, stripes, etc.) and solid white socks. Read carefully **Rule 4-1** in the NFHS Soccer Rules Book. You may also reference the [NFHS UNIFORM REQUIREMENTS DOCUMENT](#).

SHINGUARDS (NFHS Rule 4-1-5) . . . shall provide adequate and reasonable protection; be professionally manufactured, **age and size appropriate**; not altered to decrease protection; be worn under the socks with the bottom edge no higher than 2 inches above the ankle; NOCSAE mark and height range shall be permanently marked on the front of the shinguard.

NFHS Rule 12-4-4: The head coach shall be responsible for ensuring each player on the team is properly and legally equipped. **The head coach shall receive the first caution issued for an illegally equipped player.**
