BOARD OF DIRECTORS MEETING FORMAT

The Board of Directors assembled at the office of the KSHSAA in Topeka, Kansas at 3 p.m. Wednesday for hearings, discussion and final action on agenda items.

President Justin Seuser advised members an item could be added to the agenda provided three-fourths of those present (60) agreed (45 votes would be required). No additions were requested.

Following public hearings, discussion and voting of all agenda items, the Board adjourned at 6:20 p.m.

EXECUTIVE DIRECTOR'S REPORT

Bill Faflick, Executive Director, called roll, presented remarks on the Association's financial position and other items relative to the state of the Association, and updated the members of the Board of Directors on business and policy matters of the Association.

PUBLIC FORUM

The opportunity for public comment on KSHSAA issues was provided. The following individuals spoke on the listed agenda items:

All agenda items approved become effective immediately upon publication of these minutes unless otherwise specified. Abstentions from voting by Board of Directors members count as an opposed vote.

Note: Words or phrases which appear underlined in the following sections indicate the changes which were made.

CLASS 6A REPRESENTATIVE TO EXECUTIVE BOARD

Due to the resignation of former Board of Directors member Drew Thon, Garden City, a vacancy required the members in Class 6A elect a new representative on the Executive Board. During the orientation breakout session, an election was conducted and Principal Eric Hofer-Holdeman of Wichita-Northwest High School was selected to serve the unexpired term.

PREVIOUS MEETING MINUTES APPROVED

M. Kastle moved, second by K. Adams, to approve the Minutes of the April 27, 2023, Board of Directors meetings. The motion passed (59-0).

BASEBALL TEAM COMPETITION NUMBER EXPANDED

A motion was made by T. Dain, seconded by A. Penrose, to modify Rule 32, Baseball, Section 2, Article 4 as follows:

Art. 4: No varsity team shall participate in more than twenty-six games of interschool competition during a season, exclusive of the state championship series. Only twenty of those games may involve the loss of instructional time. No team (at any non-varsity level) shall participate in more than twenty games of interschool competition during a season, exclusive of the state championship series. Only ten of twenty non-varsity playing dates may involve school time. A student may participate in twenty-six games of interschool competition during the season, exclusive of the state championship series.

Note: A student who participates in more than twenty-six games during the season is ineligible until reinstated by the Executive Board.

The proposal was approved by a vote of 42 in favor, 17 opposed.

STATE GOLF TOURNAMENTS EXPAND NUMBER OF DAYS

A motion was made by P. Zuzelski, seconded by T. Dain, to modify Rule 36, Golf (Girls & Boys), Article 3 as follows:

Art. 3: The state tournament

- a. Girls Shall be held on Monday <u>and Tuesday</u>, insofar as possible, of Standardized Calendar Week #16. Regionals, when needed, will be held the previous week.
- b. Boys Shall be held on Monday <u>and Tuesday</u>, insofar as possible, of Standardized Calendar Week #47. Regionals, when needed, will be held the previous week.

The proposal was approved by a vote of 59 in favor, 0 opposed.

INACCURATE GOLF LANGUAGE REMOVED

A motion was made by M. Kastle, seconded by D. Strecker, to modify **Rule 36**, **Golf (Girls & Boys)** by removing **Article 6** as follows:

Art. 6: The Executive Board may schedule summer tournaments, if a sufficient number of schools enter summer competition.

- c. A school shall not participate during the school year and in summer competition.
- d. A school shall declare its choice in advance.

The proposal was approved by a vote of 59 in favor, 0 opposed.

SOFTBALL TEAM COMPETITION NUMBER EXPANDED

A motion was made by L. Wiley, seconded by T. Dain, to modify Rule 39, Softball, Section 2, Article 5 as follows:

Art. 4: No varsity team shall participate in more than twenty-six games of interschool competition during a season, exclusive of the state championship series. Only twenty of those games may involve the loss of instructional time. No team (at any <u>non-varsity</u> level) shall participate in more than twenty games of interschool competition during a season, exclusive of the state championship series. Only ten of twenty <u>non-varsity</u> playing dates may involve school time. A student may participate in twenty-six games of interschool competition during the season, exclusive of the state championship series.

Note: A student who participates in more than twenty-six games during the season is ineligible until reinstated by the Executive Board.

The proposal was approved by a vote of 48 in favor, 11 opposed.

RULE UPDATES PER KANSAS LEGISLATION

Mr. Faflick led a discussion with Board members on Kansas legislation made at the end of the last legislative session that impacted KSHSAA rules and procedures.

The first piece of state legislation discussed was House Bill 2238 or the 'Fairness in Women's Sports Act' regarding transgender student eligibility. It was determined no additional rule modifications were necessary at this time by the Board of Directors as the policy adopted following this legislation remains appropriate.

The second piece of legislation, House Substitute for Senate Bill 113, introduced challenges to **Rule 18 Transfer**. In response, two exceptions to **Rule 18, Transfer, Section 1, Article 4** were introduced and discussed in an effort to provide consistent application of transfer eligibility for students transferring from non-member school under specific circumstances. Both of these exceptions provide the possibility of varsity eligibility for the student. The current language detailed in the KSHSAA Handbook follows:

Art. 4: TRANSFER FROM NON-MEMBER SCHOOL—Students who transfer from a school which is not a member of the KSHSAA or an Association of any state as recognized by the National Federation of State Associations, may be declared eligible at the non-varsity level by the Executive Board. (Process Form T-E/P—Send a copy of it and a letter of request for eligibility to KSHSAA, identifying the non-member school.)

Following discussion, a motion was made by K. Adams, seconded by J. Webster to modify **Rule 18, Transfer, Section 1, Article 4** by adding the following exception:

Exception: A non-member school student may be granted varsity transfer-eligibility upon return to the member school most recently attended.

The proposal was approved by a vote of 59 in favor, 0 opposed.

A motion was then made by C. Seyfert, seconded by D. Strecker to modify **Rule 18, Transfer, Section 1, Article 4** by adding the additional exception:

Exception: A student participating on a member school team while attending a non-member school may be granted varsity transfer-eligibility upon enrollment at that member school.

The proposal was approved by a vote of 59 in favor, 0 opposed.
