- 13. Officials Uniforms The KSHSAA utilized guidance from the NFHS relative to uniforms for officials while attempting to minimize cost for officials. Recently,

softball umpires have inquired about a navy blue option in addition to the approved powder blue shirt and the Executive Board will consider approval navy to be worn by softball umpires. (In comparison, baseball umpires have the choice of black or navy). Similarly, volleyball officials wear while and the NFHS has just approved gray or bright blue. While the KSHSAA will volleyball officials will only wear white this year, the staff requests Board input on expanding the selection for future years.

14. Weskan Membership Status – Due to inability to enter into a cooperative agreement with non-member schools, Weskan High School and Middle School have withdrawn from the KSHSAA.

The staff would like input into whether or not Weskan should be included as part of the district football assignment process for the upcoming cycle. –*See Support Material*– (Information/Discussion, Action)

15. **Unified Bowling** – As the KSHSAA prepares for the initial year of Unified Bowling, staff will provide an update on plans for the season.

Additionally, staff recommends the Executive Board provide approval for the use of ramps for bowlers when physical conditions warrant (consistent with historic protocol used in interscholastic bowling). The ramp allows for wheelchair or prone bowlers to participate in the game. The ramp is placed at the front of the lane and lined up for a direct path to the pins. The bowler would be responsible to align the ramp and initiate the attempt by applying a slight push to the ball to send it rolling down the alley. **(Information/Discussion/Action)**

18. Possible Rule Revisions

- a. Driven by COVID-19
 - i. Provide one year of eligibility for FES students who planned to attend a Kansas school in 2021-22 but were not able to travel and subsequently returned to Kansas after graduating from home country high school.
 - ii. Provide remedy for scholarship challenges faced by many students due to COVID19; possible options to consider:
 - defer to local control
 - waive all requirements
 - reduce requirements to less than 5

- iii. Provide relief from transfer rule for students who transferred under 18-1-4 back to the school they previously attended.
- iv. Allow transfer hardship due to COVID related reasons.
